We seek to foster the maintenance and improvement of property in the community and take a non-commercial, nonsectarian and nonpartisan approach to all problems involving residents, their boards, committees and chambers of local governmental bodies, so that the community may be informed of the actions of those bodies. The RHA supports and executes community improvement projects and other civic functions when such action is requested by the membership.

During the past year, RHA Executive Council board members have attended numerous meetings with city government officials and various city departments. They have also met with other concerned organizations to implement plans for better city service and planning. They have taken an active part in publicizing the Park Del Amo (Madrona Marsh) issue.

#### HILLSIDE OVERLAY ORDINANCE-- MIGHT IT BE RE-EVALUATED?

Rivierans with scenic ocean views or with panoramic city views will be especially interested in the spring general membership meeting on Wednesday, April 28th at 8:00 p.m. at the Lycee Francais (formerly Parkway School). Following the election of RHA Executive Council officers for the 1982-83 year, the Hillside Overlay Ordinance will be examined in terms of its implications for the Riviera. (For those new to the area, the Hillside Ordinance, as it is generally called, protects the property owner's view rights from "significant" impairment by new construction or home improvements.) A number of questions have come up lately concerning the application of this ordinance to homes under renovation in the Riviera. At this RHA meeting, representatives from the Torrance City Planning Department and the Torrance Planning Commission will serve as resources to answer your questions about:

- 1. What is the process to be followed if I decide to improve my home?
- 2. As a homeowner, what rights am I guaranteed by the Hillside Ordinance?
- 3. Is the issue of "trees" affected by the Hillside Ordinance? (And if not, what can or should be done about trees? Are they a problem?)
- 4. What changes in the Hillside Ordinance can we anticipate in the future? Might it be "weakened" by impending legislation?

Come and meet your Riviera neighbors, enjoy light refreshments and get some straight information on these and others matters of concern to all of us. Once again, it's:

"But I thought that Riviera Homeowners' is the Hollywood Riviera Community Association!" This reaction is common when people discover that the two organizations are quite separate, and have very different functions. Many Rivierans discover the existence of the Hollywood Riviera Community Association (hereinafter abbreviated HRCA) only when they undertake exterior remodeling and learn that the HRCA art jury must approve their plans.

Jurisdiction of the HRCA extends to Tracts 10300, 10302, 10303, 10304, 10306, 10307, 10308, 11920, 14890, 15211, 18379, 19305, 19306, 20504 and 28469 (check your tax bill to see if you're included!). The authority and responsibilities of the HRCA are delineated in the Covenants,

Conditions and Restrictions of record covering these tracts. If you're interested in obtaining a copy of the CC&R's which apply to your property, consult your local realtor, or the Los Angeles County Hall of Records.

The Hollywood Riviera Art Jury appointed by the HRCA Board of Directors reviews and approves plans for all new and remodel construction within its area of jurisdiction. Such approval must be obtained through separate application and in addition to City of Torrance approval. # Winning a ? losing battle

PARK DEL AMO:

CONTROVERSY CONTINUES

As this newsletter goes to press, the fate of the Park Del Amo Project slated for development on the old Santa Fe property adjacent to the Del Amo Center may rest with the voters of Torrance. The City Council voted on February 23, 1982, to approve the zone changes requested for the property, but a citizens' coalition is attempting to force the Council to rescind that vote. Calling itself S.T.O.P. for "Stop Torrance Overdevelopment by Petition," the coalition includes representation from and has the active support of many Torrance homeowners' organizations, the League of Women Voters, Torrance P.T.A., Friends of Madrona Marsh, and Citizens for Moderate Growth. The group is attempting to gather the signatures of 7,000 registered Torrance voters by April 8th on a petition addressed to the City Council which would require either the reversal of the Council's original decision on the zone change, or would put the matter to a public vote.

A majority of the RHA Executive Council officially voted to endorse the efforts of S.T.O.P. and to permit RHA's name to be associated with the petition drive, in the interest of promoting greater citizen awareness of the issues of planned community growth, open space and traffic density as they affect present and future property values in the Riviera. As I write to you for the last time as your RHA president. I am reminded of a Pogo cartoon that appeared more years ago than I care to admit. The message has real staving power, though, and I wouldn't be surprised if you have heard it, too. In

the final frame of the strip, Pogo announces ruefully, "We have met the enemy, and he is us!"

I often think about this in the context of local events. People ask me, "Why on earth did RHA take such a stand on (blank) issue, or recommend (blank) policy to our elected officials?" My answer is simple: "Because it's my job as president of this organization to represent the views of the majority of its members--to the extent that I am able to discover what the majority thinks -- in all issues and on all occasions when the civic service mission of the RHA requires it. If you happen not to share the views of the majority--and sometimes, even I do not--it is YOUR job to make your wishes and needs known to those who can do something about your problem."

How many of us are ready to do this in everyday life? As your president, I've sat through more meetings (and missed more Monday night football games) than I can easily recall. I'm not complaining; after all, I volunteered to do this, and I knew exactly what I was getting myself into. What amazed me, though, and continues to amaze me even as I write, is how FEW other people attend those meetings, or express any position at all. How many times, at city council meetings, have I encouraged people to stand up and express their views, only to be told, "Wouldn't you please speak for me? After all, you'll make such a good impression, and I'd be too nervous to remember what I want to say."

Good grief--is this what representative democracy has come to mean? I refuse to believe that any citizen of Torrance who goes to school or holds down a job or runs a household cannot get up in front of his/her fellow citizens to say what needs saying. But as long as we convince ourselves that someone else will do it, some RHA officer or elected official or anyone-except-me, we've got a problem. And the problem, my friends, is us. Too many times, we view politics as a spectator sport.

It's an interesting experiment, this American dream that we are working on in our seaside community here in Torrance. But it's a fragile dream as well. I encourage those of you who feel that there might be a better alternative to letting the other fellow do it all, to begin your own involvement with a local organization such as RHA. And for those with a long history of distinguished community service who've perhaps gotten a bit out of touch lately, guess what? Your expertise is more valuable now than ever!
