At least that is the feeling in our one block on Colinas since our watch was established. Believe me, this program does work!




## Letters, Editorial & Opinion

The Coalition to Stop Torrance Overdevelopment Plans (STOP), of which RHA is a member, is proposing an initiative ordinance to deal with the property bounded by Sepulveda, Madrona, Monterey, Toledo and Crenshaw. This property is the site of the proposed Park Del Amo project (including Madrona Marsh), which was stopped by a STOP referendum drive last spring.

Many residents of Torrance have found it necessary to join together in this coalition and take the citizen initiative approach, largely because of the city's approval last spring of development plans which the citizens deemed unacceptable, but also because they wish to make a strong statement in favor of a policy of moderate development.

To quote from the coalition, "the purpose of STOP is to support moderate, well-planned growth in the city of Torrance and to adhere to the concepts of a balanced community and protection of the environment, by preserving open space and ecological resources now present in the City and providing protection to the citizens from excessive traffic congestion, noise and air pollution. Its specific goal is to ensure the reasonable and moderate development of the property bounded by Sepulveda, Madrona, Monterey, Toledo and Crenshaw, and the preservation of a 54-acre Madrona Marsh."

With that in mind, it has designed an initiative ordinance which will rezone the property to set a reasonable cap on the allowable residential, office and retail density. It will also preserve Madrona Marsh as open space at no cost to the City and provide for the transfer of development rights from the marsh portion to the portion east of Maple so that the owner and developer will not be deprived of his reasonable rights of development.



Kay White, a League of Women Voters representative from the coalition, will be at the general meeting on October 14 to explain the initiative and answer any questions you may have.
