GROUP W CABLE

The City has responded to our letter of last October protesting the cable company's use of our easements without prior consent. In effect, according to the City Attorney's opinion, there is nothing the City needs to do in our behalf, so everything is on hold for now. However, there are some recent court actions, one involving a possible appeal to the Supreme Court in a situation very similar to ours. We will be tracking this to see what develops.

On Tuesday, April 16, the City Council will hold its 3-year performance evaluation of Group W. This is a public hearing to receive comments from citizens. You are urged to come to the meeting and speak up if you are interested in commenting, pro or con, on Group W's performance and quality of service.

HILLSIDE ORDINANCE

Substantive changes to the "emergency" Hillside Ordinance have yet to be taken up by the Planning Committee of the City Council. As a result, we have not yet been able to get any feedback on our proposed revisions at a public hearing. A meeting of the committee is scheduled for April 11; however, as of this writing we do not know if we will be given time on the agenda. Stay tuned, and be prepared to come out in support when it gets to the City Council!

NEW SEWER SYSTEM SERVICE CHARGE

Starting in 1985-86, our local Sanitation District will begin charging homeowners a service fee. The proposed charge will be \$12 per year and will appear as a separate item on your property tax bill. The charge will likely rise to \$20-\$25 in future years. Several other sanitation districts already impose such a charge, and our district faces a budget deficit due to drawn down reserves and lack of federal and state grants.

Single family homes which use less than 9 ccf (hundreds of cubic feet) per year can qualify for a reduction of \$7.50. This usually applies to a 1-2 person household. You can look on your water bill or call the water company to find your yearly consumption. You must apply in writing to the Sanitation District for this reduction before May 31, 1985.
