

TREE VIEW IMPAIRMENT SURVEY

Riviera Homeowners Association has historically been committed to preserving the values of the Hollywood Riviera. The RHA has provided leadership in several areas that affect home values in the Riviera such as support for strong schools and initiation and support of the Hillside Overlay District. As time passes, we are becoming aware of a "growing" problem in the Riviera, namely trees and vegetation planted years ago have now grown so tall that ocean and city-lights views once enjoyed by residents have been obliterated, through no fault of their own.

Many RHA members have asked the RHA Board to take a position and champion a process, similar to our past efforts with the Hillside Ordinance, that would allow mitigation of this expanding problem. However, the Board recognizes that lush vegetation is also a trademark of the community, along with the view, so a balance must be struck. To obtain the current pulse of the Riviera, the RHA Board is embarking upon a fact finding mission to determine the opinions and feelings of the community.

This search for current opinions will include a two step process: 1) A short written questionnaire is enclosed in this newsletter. It is being sent to all of the approximately 3,400 homes in the Riviera, not to



just our paid membership. The best fastest method communicating your opinion is to fill out this questionnaire, clip, and mail it to us. 2) The RHA Board will call a geographically representative sampling of homes in the Riviera to conduct a telephone poll of these same questions. Please note that the phone sampling will involve a relatively small number of calls so there is no guarantee that your views will be reflected unless you send in the questionnaire. Based on these two steps, we hope that a consensus may be gathered so the RHA may proceed with formulation of an RHA Vegetation View Policy and use this consensus for further discussions with the city council and staff.

Airport Report

The Airport Commission meeting on June 12 addressed new hangar leases and a report by **Dr. McFarland**, a consultant hired by the Airport Manager to evaluate the Torrance "Instrument Landing System", or ILS. Airport Manager Andy Hriz said that Dr. McFarland found the ILS equipment to be in poor shape and needs replacement. The Palos Verdes hill and the High Shear water tower cause significant distortion of the ILS signal. His written report is expected in late summer or fall.

A number of RHA members have been asking why Torrance paid over \$325,000 last year for noise monitoring activities. Apparently, that's 20 to 30 times as much as it costs other cities with airports similar to Zamperini Field. Torrance pays more per flight operation than does Long Beach, and more than LAX. Possibly the real noise pollution caused by airplanes may be overstated. A study of complaints made since January 1, 1997 reveals that less than 10% were valid. It seems only 12 people made one-half of the airport complaints over the last two plus years. One person lives over 3 miles from the airport; another lives over 7 miles away. The person on record as making the most complaints last year is an airport commissioner. After this information was revealed, the City took steps to prevent further public release of the names and addresses of noise complainants.

Landscaping & Lighting Balloting

Property owners in the City of Torrance recently received a revised ballot to vote on the Street Lighting & Street Landscaping District No. 1. The second ballot was due to an update of the County Assessor's records that were woefully

outdated. This balloting format is required by recently passed Proposition 218 that requires a vote by landowners on such assessments. Prop. 218 sets the format for the votes, calls for mail in ballots vs. in person voting, and requires parcel identification on the ballots vs. secret voting. The city cannot control the voting format. This assessment pays for two types of items:

- 1) The energy costs, operations, and maintenance / upkeep for street lighting and traffic signals. This is an ongoing process which continues the existing assessments we have been paying for the past 20 years, first started with the "Street Lighting Act of 1919" in the state vehicle code.
- 2) Increased services for landscaping around street lights and signals to enhance safety, upgrade appearance, improve pedestrian visibility, and allow clean-up / improvements to street medians and parkways. These

are additional tasks above the present level of service being offered.

Despite the additional levels of service, the proposed Assessment District No. 1 calls for a per property cost equal to the current levels.

Property owners will not pay more, but will receive additional and better use of the funds. The assessment may increase each year but may not exceed the local consumer price index without holding another Prop. 218 election. There is only one ballot per parcel. There are several rates for various types of parcels and fee rates in the city, including: Residential;

Hillside Residential; Non-Residential; and Institutional. Please note that as a "hillside" area, properties in the Hollywood Riviera pay the lower fee per parcel assessment due to a lower level of lighting used in the neighborhood versus general residential areas. Ballots will be weighted by the amount of assessments and a simple majority is needed to continue the assessment. The ballots are due, signed, and returned to the City Clerk's office by August 5. Postmarks do not count, so mail early! For more information, call the Assessment Hot-Line 1-800-424-9144. Glenn Tanner
