Begonia Farm Development

Anastasi Development has filed a proposed 64 unit town-home development with the Torrance Planning Dept. Interested residents and the developer have met in an effort to workout a revised plan which decreases density and enhances the value of the neighborhood. No formal plans have

yet been drawn. The consensus of my contacts with many neighbors has lead us to request a revised development of 2-story single family type "patio homes"

numbering around 45 units

and Anastasi has provided such an alternate plan. Additionally Anastasi 's architect is working in conjunction with resident input on a proposal to the City to reconfigure the intersection of Newton and 242nd Street. The first hearing on the Begonia Development is tentatively scheduled before the Environmental Review Board on February 18, 1998 at 3:00 p.m. So, what can you do to assure a responsible, harmonious, and enhanced development? Additional letters of concern regarding the development and traffic are needed

from Newton/Walteria area residents at this time. Please send your letters to **Mr. David Ferren**, Director, City

What's Up In the Neighborhood:

HILLSIDE ORDINANCE CASES

The following locations are scheduled for a Hillside Overlay District precise plan hearing or have recently been heard:

105 Paseo de Granada. Planning Commission consideration to allow a second story addition to a one-story single family dwelling.

965 Calle Miramar. Planning Commission consideration to permit an existing oven and patio cover to remain in the side yard.

425 Via La Selva. Planning Commission consideration of a minor hillside exemption to allow construction of a fence, deck, spa & planters under ten feet in height.

16-screen theater complex, restaurant area, renovation of nearly 30,000 SF of existing retail space, and construction on new parking structure. Project is bounded by Fashion Way to the north, Madrona Av. & Del Amo Circle East to the east, and Hawthorne Bl. to the west.
