# WHAT'S UP IN THE NEIGHBORHOOD:



## UNDERGROUND UTILITIES

**District 1** was chosen by the city to proceed as the first district, due to its uniqueness. Eighteen of the 27 lots in this district are on leased land. It has a small compact size and only one side of the street will need to be underground, therefore it does not entail working with adjoining lots either behind or in front of each property.

Although the improved property owners pay the property taxes, the project has been stalled since January 2002, when the city attorney required the approval of the owners in fee of those lots.

After several meetings with the Engineering Department, on November 27, 2002 the city attorney revised petition instructions and created a Waiver of Proposition 218 Right to Vote for the owners in fee. The Waiver acknowledges the establishment of an underground assessment district that includes the 18 properties that the fee owners own. The waiver waives their rights to vote on the proposed assessment. This waiver was created to remove any liability for the fee owners.

The instruction for Petition Signatures has also been modified to reflect that the parties responsible for paying assessments will be the lessees and their signatures will be required on the new petition.

As of December 2, 2002, the fee owners have not responded to this waiver. Two thirds of the 18 lessees have signed the previous two petitions and want the assessment. The city only requires a 60% positive response. Under Proposition 218, those property owners who do not want the assessment district will be required to pay for it if the majority (over 50%) desire the assessment.




## **OUTSTANDING LANDSCAPE AWARDS**

Here are the winners for the months of December and January.



Couderc, 137 Via La Soledad. This festive holiday landscape was especially beautiful at night with small twinkling lights on all trees and shrubs and dramatic landscape lighting hilighting an abundance of red poinsettias,

grouped in masses along the driveway, entry and everywhere. Compliments for this exquisite display must be given to Villa Hermosa who provided the design and labor.



Abramo of Unique Environments in Redondo Beach carved a meandering dry stream bed in a diagonal swath across the front of their property. This stream bed, filled with rocks and magnificent Sonora Gold boulders will divert all rain and water runoff to the driveway and then downhill and away from their foundation. Instead of sod, Greg hydroseeded red fescue which will resemble a meadow and will grow quickly in the shade of many mature trees whose large roots were carefully saved during all the construction. Other landscape highlights are Japanese Maples, campanula, azaleas, princess flowers, orchid trees and hundreds of daffodils, which should be coming into bloom shortly.
