PRESIDENT'S MESSAGE: SPITE TREES AND A RECENT LAWSUIT

Last fall, the President's message was about being a good neighbor with regards mostly to remodeling and trees. Sadly, the following is an example of the opposite.

Recently this year, I attended a trial in Torrance concerning two Hollywood Riviera residents and spite trees.

The case is about a Hollywood Riviera resident (neighbor 1) who filed a lawsuit against another neighbor (neighbor 2) who lives on a street just below neighbor 1. Neighbor 1 felt that neighbor 2 planted trees in spite to take away much of the views that neighbor 1 has had for 45 years due to considerate neighbors trimming their trees.

This is the background of events before the tree spite lawsuit was filed:

- In 2005, neighbor 2, <u>before</u> purchasing a home on the street, went to some of the neighbors to find out what impact building a second story and/or expanding his first story would have on their privacy and views. He then bought the home in 2005.
- In 2006, neighbor 1 voiced his objections to neighbor 2's next door neighbor's (neighbor 3) proposed second story citing the Hillside Overlay Ordinance at the hearings where ultimately the second story proposal was denied.

Treasurers candidates Dana Cortez and Steve Groom will make a short statement and provide campaign literature.

Both sides will give short statements on Measure A - date of the City Elections Save June 9th for last RHA meeting of year • In June of 2008, neighbor 1 sent 3 certified letters to neighbor 2 asking him to trim the trees at the expense of neighbor 1 to restore his views. Neighbor 2 responded with, "No, sue me." After that, neighbor 1 said that he felt that he had no other choice but to file suit alleging violations of spite fence law and nuisance law. The fast growing trees in question grow approximately 1 foot a month and now are approximately 35+feet high.

In the tree spite lawsuit neighbor 1 alleged that neighbor 2 purposely planted fast growing trees in the beginning of 2008 on one side of his property and stopped maintaining his other foliage to:

- 1. Obscure the views for the purpose of spite to neighbor 1 because of neighbor 1's involvement in opposing neighbor 3's second story project
- 2. Bolster his own plan to build a second story by showing that neighbor 1 no longer has any views by newly planting the trees.

During the time the lawsuit was being litigated:

• In August of 2009 neighbor 2 placed silhouettes flags on their rooftop for a proposed second story. It is clearly seen that the majority of the fast growing trees planted by neighbor 2, which block neighbor 1's views are inside of the silhouette flags which means that the newly planted trees will be cut down and replaced with the proposed remodel if a second story is built. Near the end of 2009, Torrance City Planning Department recommended to the Planning Commission that the second story project by neighbor 2 be denied.

In 2010 the spite tree lawsuit continued to trial:

• Midway through trial, the parties agreed on a settlement of the matter wherein neighbor 2 agreed to trim and maintain the fast growing trees to maximum of 14 feet, and other foliage in question to maximum of 10 feet and 6 feet.

Homeowners whose views are affected by a neighbor's foliage may have recourse under various California statutes. Spite fence law applies not only to manmade structures (i.e. fences, buildings) but also to trees and foliage that has been planted with the intent to create a fence and obstruction of view (see Civil Code Section 841.4. Wilson v. Handley (2002) 97 Cal App 4th 1301, 1313.) This case expands the law to include more than manmade structure, specifically trees.

I hope that we as homeowners learn to coexist by understanding the impact you and your property can have on your neighbors around you. As the Golden Rule states "Do unto others as you would have them do unto you."

TORRANCE POLICE

Over the past several months, our City of Torrance has experienced an increase of daytime residential burglaries. We are asking our community to be more aware of people in their neighborhood who they do not recognize as residents of the block, and/or, individuals acting suspicious. For example, in two of our recent daytime burglaries, neighbors saw a subject in a neighbor's backyard that they did not recognize as a resident of the house and did not call us. Both of these houses were broken into. Please call the Torrance Police Department (310-328-3456) regardless of how insignificant you feel a situation may be.

NEW HELICOPTER IN TORRANCE

You may have noticed the different looking helicopter (see photo) that recently began flying over our area several times a day. It's a jet-fueled Bell, Model 407, larger (seven seats) and noisier than the Robinson type we are used to seeing. It arrived at Torrance Airport a few weeks ago. Hollywood Riviera resident, Richard Root, who has been dealing with helicopter noise issues, contacted the owner and was told it's supposed to be based here for about 6 months while its pilots are training. After that, it's supposed to be shipped overseas for service in another country. When told about the noise it was causing, the owner indicated he would talk to the pilots and ask them to avoid our area.

In December, last year, Richard submitted a petition (with the names of 169 area residents) to the Torrance City Council, asking for their help in reducing helicopter noise. As a result, a roundtable meeting is being planned with the City, FAA, Coast Guard, Robinson, and other helicopter operators to discuss the noise issues. 



The Gaffarey's have been refreshing and remodeling their home on Miradores over the seven years they have lived here (first as newly weds and now with two small children).
