News and Updates:

Challenges continue for Riviera homeowners, so here's the very latest on what you need to know:

<u>Tree Ordinance</u>: We are looking forward to the first Public Hearing on a Tree and View ordinance at Torrance City Hall that is targeted at providing homeowners in the area with a process for handling disputes between neighbors. The date is planned for early January,

<u>PCH Beautification:</u> Lea Reis of the Torrance Public Works Dept. told us this week that all necessary reports had been submitted from Torrance to CalTrans Traffic Engineers, where they will be reviewed. After the reports are approved, a permit will be issued for construction of a fence and landscaping on PCH. Then the job will be open for bids. The project is expected to happen in 2016.

<u>Water Efficient Workshop:</u> The City of Torrance, and the Metropolitan Water District of Southern California (MWD), are sponsoring several sessions of an innovative Water Efficient Landscape/Gardening Workshop, at no cost to participants. Workshops will be held on **Saturday mornings, Nov. 21 & Dec. 12 from 9 a.m. until noon at West High School.** Participants will learn how to reduce their water use in an efficient and environmentally friendly manner while maintaining an aesthetically pleasing landscape. <u>Mixed-Use Zoning, Redondo Beach and why this matters to you!</u> Recently, the Redondo Beach City Council approved plans for a controversial 52-condo development, with 10,000sf of commercial space, to be erected in the Sea Breeze Plaza, on PCH off Prospect.

There is a much larger scaled mixed-use development the Planning Commission will soon be reviewing on the old Bristol Farms site. The latest plan calls for 149 rental units, accompanied by almost 40,000sf of commercial space, along with the 110-rooms of a renovated Palos Verdes Inn. The Planning Commission has demanded a "substantially" revised plan to be submitted by the developer, but no new revisions had yet been presented as of this writing.

This development will affect all residents in the area whether they live in Redondo or Torrance. No one is against development, we simply want to ensure that it be appropriate development, and not overly dense for our beach community.

If this issue concerns you, then you need to join us and speak up. Please plan to attend the November 19th hearing at 415 Diamond Street (off PCH), to make your concerns heard. If you can't attend, then write letters to the Redondo officials, and to our local newspapers, as well. We will post all appropriate email addresses on our own RHA website, http://hollywoodriviera.org/. Also, check into residents' SaveRiviera.org website to make sure that Redondo doesn't postpone this hearing at the last minute. We all know how often we see a problem after it's too late to change it. Well, the good news is here's a problem that we CAN work to fix. For the sake of your children and your neighbors, make your voice heard! Before it's too late.
