CANDIDATES FOR COUNCIL AND MAYOR TO ADDRESS HOMEOWNERS AT APRIL 6 MEETING

Riviera voters, faced with a bewildering lineup of 19 candidates for three Torrance City Council seats and an exciting mayoralty race, will have an opportunity to see and hear the contenders "in person" at the April meeting of the Riviera Homeowners Association.

Invitations have been extended to all candidates for council and mayor in the April 14 election, and all of the leading aspirants have indicated their intention to be present. Each will have an opportunity to state his views on the campaign issues, and, as time allows, members of the audience will be invited to present questions to the candidates.

The meeting will be held on Monday, April 6, at the Parkway Elementary School Cafetorium (220 Via Riviera). The program is scheduled to get under way at 7:30 p.m. --- a half hour earlier than usual because of the long roster of speakers and the importance of the meeting.

This meeting, as all other regular meetings of the Riviera Homeowners Association, is open to the public. A special invitation has been extended to members of the Southwood Homeowners Association to join in meeting the candidates on this occasion. A heavy turnout is predicted, so come early!

HIGH DENSITY APARTMENT REQUEST WITHDRAWN

The developer's request for a conditional use permit to allow construction of a high density apartment complex between Pacific Coast Highway and Newton, near Anza, on property presently zoned C-2, has been withdrawn.

Withdrawal of the request, which had been approved by the City Planning Commission, brought cancellation of a scheduled hearing on the matter by the Torrance City Council. The Riviera Homeowners Association had expressed opposition to the conditional use permit on grounds that a formal rezoning procedure should be followed before permission should be granted to allow residential construction on property now zoned for commercial use.

Further action on plans for the property will now await renewal or revision of the developer's request. The Homeowners Association will follow the matter closely and keep the membership advised.
