#### ON THE CALENDAR ... AIRPORT DECISION

There's more to the Torrance Airport than noise and an occasional jet. City Council is expected to authorize the Airport Commission to hold a public hearing March 9th on suggested plans for forty acres of property along the western border of the Airport. All city residents have a stake in the development of this acreage and the city policies which determine its use. We urge local residents to expand their knowledge of the Airport and to take an informed part in deciding its future.

#### PALOS VERDES APARTMENTS - CONDOMINIUMS?

Legal notices were posted recently within a 300' radius of the Palos Verdes Apartments (bounded by Palos Verdes Drive, Calle Miramar, Camino de las Colinas and Calle Mayor) announcing the March 1st Planning Commission public hearing on conversion of the 156 unit complex to condominium.

The conversion is simply a matter of changing the form of ownership so that individuals could purchase single apartments. It is expected that before such conversion took place maintenance would be upgraded and more off-street parking provided. The plan would not include new or enlarged buildings. The hearing will be held in Torrance City Council Chambers at 7:00 p.m. March 1st.
