LETTER FROM THE PRESIDENT

Overwhelming community involvement and concern were dramatically demonstrated by the unprecedented turnout of the concerned citizens at the recent public meetings of the Torrance Airport Commission. The meetings were ostensibly intended for presentation of development options for our information, but what they became were forums for the many groups and individuals to go on record, sometimes quite colorfully, to make known to all their opposition to any expansion in any form of airport traffic because of noise and safety hazards.

The position of Riviera Homeowners Association was expressed, to recommend actual curtailment in certain cases, and to provide better accountability for violations of air traffic regulations. Many of our individual members made their views known as well.

There is little doubt now that lawmakers, at least on the local level, are well aware of the nearly unanimous grave public concern regarding airport noise, jet traffic and air commuter service. However, the advantages gained by public response were rendered unclear by a very recent 5-4 decision of the U. S. Supreme Court, in which the city of Burbank's ordinance to ban jet flights during nightime hours was struck down, due to the federal government's stated preemption of control of air traffic flow.

The significance of the Burbank decision is unknown at this point. Some believe that it will work to the advantage of nearby homeowners in that it will in effect force federal legislation to protect their interests.

We contacted the office of one of our U.S. senators regarding the Torrance airport problem generally, and were advised that the senator has no position at this point, but would like to listen to and carefully consider what we say.

Particularly considering the possible implications of the Burbank decision, and in view of the probable crucial role to be assumed by the federal government, here is a classic case calling for citizen involvement, where writing one's congressman can and should achieve tangible results, just as we feel community participation has done at the local level.
